- b) **Review and possible discussion of the Speed Limit Evaluation on Estrella Road Between HWY 68 and Shinarump Road.**

PURPOSE: The majority of vehicles on this road travel much faster than the statutory speed limit. The focus of this study is to determine if additional traffic control devices are needed or if modification to the existing devices is required.

RECOMMENDATION: The speed limit of this road should not be changed. The road directly connects to the driveway of many residences, cattle-crossing is a prevailing and recurring issue in this area, there exists a significant dip in the road that already forces drivers to travel at lower speeds, and the narrowness of the lanes provides physical and psychological discomfort to vehicles and their drivers, especially during or after rainfalls which will cause vehicles to lose traction more easily and has a likelihood of flooding the road.

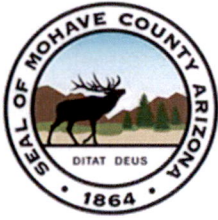
Finally, even if the speed of this segment of the road were increased to 55 mph, a vehicle would still only travel the full 4.8-mile length of this road in 5 minutes and 14 seconds. A vehicle traveling 45 mph along the full 4.8-mile length of the road would achieve this distance in 6 minutes and 24 seconds. Increasing the speed of this road may have a high likelihood of increasing the frequency and magnitude of all crashes in exchange for vehicles to shorten their driving time on this road by 1 minute and 10 seconds or less; The expected value of this event is insufficient.

Instead of increasing the speed limit of this road, additional warning signage of cattle crossings should be implemented between Chuar Drive and Abrigo Drive. Cattle-related crashes frequently occur at night between these roads, and so “Watch for Cattle” Pavement Markings should be put in place as well as W11-4 Warning Signs, which should be installed at the locations provided in Figure 9 marked with a Red X. These locations are Northbound Estrella Road just North of Chuar Drive and Southbound Estrella Road just South of Abrigo Drive. Mohave County Traffic Signing and Striping policy instructs to provide minimum retroreflectivity levels on the W11-4 signs in accordance with MUTCD 11th edition Table 2A-5.

Sergio Gudino approved the motion. Gregg Swierczek seconded the motion. The motion was voted on and carried unanimously.

b) Review and possible discussion of the Speed Limit Evaluation on Estrella Road Between HWY 68 and Shinarump Road.

MOTION: Accept findings and study and place "Watch for Cattle" signs as well as W11-4 Warning Signs on Northbound Estrella Road just North of Chuar Drive and Southbound Estrella Road just South of Abrigo Drive.

Steve Latoski motioned to approve. Steve Vest seconded the motion. The motion was voted on and carried unanimously.


c) Discussion and possible action to consider cancelling the December 11, 2025 TSC Meeting.




