VALLE VISTA REMNANT ROAD RESTORATION PROGRAM

Board of Supervisors Resolution No. 2023-215 as amended

IMPLEMENTATION PROCESS

Prerequisite Requirements

- Pertains to qualifying remnant roads ("road" or "roads") established in BOS Resolution No. 2023-215 as amended.
- Program improved roads must connect to an existing County maintained road.
- A road(s) must be improved in its entirety for the limits described in BOS Resolution No. 2023-215 as amended.

Process

- 1. Public Works will advise any private entity (i.e., a property owner abutting a road or agent thereof) applying for a driveway permit of the remnant road restoration program.
- 2. A private entity contacts the Public Works Department Engineering Division when interested in improving a road(s).
 - A. Private entity will obtain a no-fee Right-of-Way Use Permit when electing to transport aggregate base or asphalt millings to their road(s) of interest.
 - B. Private entity(s) will remit calculated total monetary equivalent, based on the amount per abutting lot established in BOS Resolution No. 2023-215 as amended, for County performance of asphalt millings transport for their road(s) of interest.
- 3. The Public Works Department will perform aggregate or millings placement, chip seal application, and roller compaction within one (1) year of Process Step No. 2 completion i.e., transport or full payment for the road(s) of interest.
