AN ORDINANCE SETTING FORTH THE ADOPTION OF FEES FOR SERVICES PROVIDED THROUGH THE IMPLEMENTATION OF THE MOHAVE COUNTY DEVELOPMENT SERVICES DEPARTMENT WATER AND WASTEWATER REVIEW AND PERMITTING AUTHORITY DELEGATION AGREEMENT WITH THE ARIZONA DEPARTMENT OF ENVIRONMENTAL QUALITY (ADEQ).

Fees for services provided through implementing the Mohave County Development Services Department, Division of Environmental Quality Delegation Agreement with the Arizona Department of Environmental Quality (ADEQ) shall be as follows:

All fees shall be payable to the Mohave County Development Services Department.


