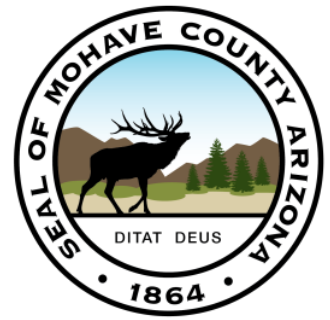

1. Review and approve the minutes of the October 28, 2024, and the April 28, 2025, Board of Health meeting minutes. **October 28, 2024, minutes were removed for additional information. Supervisor Gould moved to approve the April 28, 2025, minutes. Vice-President Strecker seconded the motion. The motion passed by unanimous vote.**
2. Review and accept the routine summary of select reportable diseases in Mohave County, April 1, 2025 – June 30, 2025. **Supervisor Gould moved to accept the report. Vice-President Strecker seconded the motion. The motion passed by unanimous vote.**
3. Presentation of Mohave County Department of Public Health Suicide Mortality Report annual review by Jessica Willard, Community Health Education Specialist, Behavioral Health and Epidemiology. **The Board received the information.**
4. Presentation of Mohave County Department of Public Health State Opioid Response (SOR) Overdose annual review by Celina Lagpacan, Community Health Education Specialist Senior, Overdose Data to Action. **The Board received the information.**
5. Presentation of Mohave County Department of Public Health Child Fatality annual review by Anna Scherzer, Epidemiologist. **The Board received the information.**
6. Mohave County Department of Public Health (MCDPH) and Kingman Regional Medical Center (KRMC) have partnered together to conduct the 2024 Community Health Needs Assessment (CHNA), a survey administered every three years to identify health needs and concerns in the community. **The Board received the information.**
7. **Discussion and possible action RE:** Per Mohave County Board of Health Bylaws, Article II, the Board will discuss and consider the status of the President and Vice President elections. Given that the last fiscal year's elections were postponed, and the current officers have served only half a year, the Board may decide to allow them to continue in their roles through the end of FY26. **Supervisor Gould moved to nominate President Litz and Vice-President Strecker as President and Vice-President of the Mohave County Board of Health for an additional year if they were willing to serve. Board Member Sheehy seconded the motion. The motion passed by unanimous vote.**
8. Commissioner comments and request for agenda items for next meeting.

Supervisor Gould requested that staff look at the US Secretary of Health and Human Services, Robert F. Kennedy Jr's recommendations for vaccinations.
