  - a) **Mountain View Road Traffic Speed Study  
Sterling Road to Boundary Cone Road (5 Miles)**

**RECOMMENDATION:**

Increase posted speed limit on Mountain View Road between Sterling Road and Joy Lane from 30 mph to 35 mph. Increase posted speed limit on Mountain View Road between Lipan Boulevard and Boundary Cone Road from 35 mph to 40 mph.

- b) **Removal of Stop Sign at a Private Roadway and Oatman Highway**

**RECOMMENDATION:**

Remove the stop sign controlling traffic on the private driveway of APN 210-55-008 at Oatman Highway.

Removal of the sign will reduce the appearance of public access, limit unauthorized use, and maintain consistency with County practices.

**c) Change Stop Control for La Calzada approaches to Gran Circulo approaches**

**RECOMMENDATION:**

1. Install STOP signs on the Gran Circulo approaches to La Calzada and remove STOP signs on the La Calzada approached to Gran Circulo.
2. Install STOP signs on the Luna Media approaches to La Calzada and remove STOP signs on the La Calzada approaches to Luna Media.

**d) Convert the intersection at Driftwood Drive and Crescent Drive into an all-way stop**

**RECOMMENDATION:**

- This intersection is recommended to be converted into an all-way stop due to engineering findings under All-Way Stop Warrant B.
- Field verify stop sign installations on Driftwood Drive to determine whether additional advisory warning signs may be necessary.

**e) Reschedule the March 12, 2026 TSC meeting to Thursday March 5, 2026 or another agreed upon date due to staff scheduling conflict.**
